- attend parent consultation meetings and discussions about my/our child's attainment and progress;
- support the school's policies and guidelines;
- support school community events;
- treat all members of the school community with care and respect
- agree to replace lost/broken equipment/resources supplied by the school for specific use by your child, or pay for the cost of repairs/replacement.

### **Viewing Films**

#### Using images of children

We are required by law to retain a photo of each pupil as part of our educational record. We sometimes wish to use digital images, e.g. photos, videos, audio recordings to enhance education provision, inclusion and recreation.

This information may be shared in order to celebrate successes or promote our education services. Please note we only share information required for that particular purpose and then only the minimum required. We may share digital images with your consent with:

- The school website provider
- Local media
- School photographer
- Essex Records Office
- Social Media platforms

As we will be relying on consent when displaying or publishing digital images, that consent can be withdrawn at any time simply by contacting the school. Every effort will be made to delete the images, but please note that where consent has been provided for the publication of the images, the school may not be able to locate and delete the image on request, although reasonable steps will be taken to do so.

No digital images are routinely available outside of the UK. However, where digital images are used on social media, in publications, or on our website we cannot restrict the access to such images to the UK.

## Use of digital images by parents/carers

During your child's time at the school, there will be opportunities for you to digitally record many of the activities they participate in, for example, sports days, Christmas shows etc. We realise that it is very important for families to be able to record the memory of these events, but we ask that this is done responsibly.

Some families do not wish their child's image to be placed in the public domain. There may be other children, who for Child Protection and Safeguarding reasons, should not have their images shared or published.

We therefore request that any images taken of your child at any school event (and that includes images of any other child) are kept private and are not reproduced or placed in the public domain via the internet or social media.

#### Consent for school trips and other off-site activities

I agree for my child:

- a) to take part in local school trips and other activities that take place off school premises; and
- b) to be given first aid or urgent medical treatment during any school trip or activity.

#### Please note the following important information:

The trips and activities covered by this consent include:

- all local visits which take place during the normal school day,
- off-site sporting fixtures inside the school day.

The school will send you information about each trip or activity before it takes place, unless it is local or regular. Written parental consent will not be requested from you for the majority of off-site activities offered by the school – for example, year group visits to local amenities – as such activities are part of the school's curriculum and usually take place during the normal school day.

#### Internet use

As the parent or legal guardian of the pupil named in this agreement, I grant permission for my child to use electronic mail and the internet at school and at home. I understand that pupils will be held accountable for their own actions. I accept responsibility for setting standards for my child to follow when selecting, sharing and exploring information and media.

I/we also agree not to publicly or privately post any information or complaints, including libelous or defamatory comments, regarding Broomgrove Junior School or any of its pupils or employees on any form of social media. I/We agree to deal with such issues by contacting the school directly, or via the school's complaints procedure, where there will be opportunities to discuss and investigate concerns or worries.
